Additional Terms

For prizes of \$1,000 or more, it is OLG's practice to publish the legal name, town/city, prize amount, game name, game number (for INSTANT tickets) or draw date, and Insider status (if any) of a winner that meets any of the criteria in the Identification of Insider and Related Parties section for a period of 30 calendar days from the date of the prize payment.

For prizes of \$10,000 or more, OLG will publish the winner's name, town/city, prize amount, game name, game number (for INSTANT tickets) or draw date and a current photograph of the winner in the medium of its choice. If the claimant has answered "yes" to any parts the Identification of Insider and Related Parties section, or if OLG reasonably believes that the claimant meets any of the criteria of the Identification of Insider and Related Parties section, it is OLG's practice to hold payments for 30 calendar days after a tentative decision to pay the claimant has been made and during this time, publish the claimant's name, town/city, prize amount, game name, game number (for INSTANT tickets) or draw date and Insider status to allow any person(s) to dispute the prize claim.

Individuals under the age of 18, or who meet any of the criteria in subsections 1.1, 1.2, 1.3 or 1.4 of the Identification of Insider and Related Parties section, at the time the individual purchased the ticket, received the ticket as a gift, or otherwise acquired an interest in the ticket is considered a "Related Party" and are not eligible to participate in an OLG lottery and are not entitled to claim a prize.

OLG may elect not to pay out on a wager, or prize on a PROLINE or POOLS ticket if OLG, in its sole discretion, has reasonable grounds to believe that a player has engaged or participated, at any time, in any form of collusion, cheating, unfair, fraudulent, or criminal activity.

The Corporation reserves the right to intercept prizes, in whole or in part, in accordance with applicable family legislation.

The Corporation reserves the right to request additional proof of identity to support the prize claim process, as required.

In consideration of and to induce OLG to deliver the prize to me, I agree that I will not make a claim against OLG for broadcasting, printing, royalty or other rights and shall have no claim against OLG for infringement of privacy rights, infringement of copyright, or otherwise due to the publication or broadcasting of my name, town/city, prize amount, game name, game number (INSTANT), draw date, my photograph, or Insider status (if any).
