



## LOTTERY PRIZE CLAIM GROUP LIST

To claim a lottery prize purchased by a group of two (2) or more individuals (each a “**Group Member**” and collectively, “**Group Members**”), one (1) Lottery Prize Claim Group List (“**List**”) is required to be completed and signed by all Group Members regardless of the prize amount. The [Lottery Prize Claim Declaration form](#) must also be completed and submitted by **each** of the identified group members in the following scenarios:

- 1) Prize claim is less than \$10,000 and each share is less than \$1,000 – Group Leader and any Group Member who came into contact with the ticket (i.e., purchased, validated or ticket checked) must complete the Lottery Prize Claim Declaration Form and provide one piece of government-issued photo identification with date of birth.
- 2) Prize claim is less than \$10,000 and each share is \$1,000 or more – each Group Member must complete the Lottery Prize Claim Declaration Form and provide one piece of government-issued photo identification with date of birth.
- 3) Prize claim is over \$10,000 – each Group Member must complete the Lottery Prize Claim Declaration Form and provide two pieces of identification, one government-issued with photo and date of birth and a second from OLG’s list of [Acceptable IDs](#).

**Do not submit Ontario Health Cards and/or Social Insurance Numbers with your claim documents. OLG does not accept either as ID for prize claims.**

Each Group Member agrees and declares as follows:

1. The Group Members are the joint owners of the lottery ticket described below in the proportions stated below.

If Ontario Lottery and Gaming Corporation (OLG) confirms the ticket as a winning ticket and approves payment of the lottery prize pursuant to the applicable rules and regulations and in accordance with OLG’s lottery prize claim policies and procedures, then this List constitutes OLG’s, or the Interprovincial Lottery Corporation’s (“**ILC**”) (if applicable), sufficient authority and instruction to make individual payments to each listed Group in the proportions stated below.
3. In case of death of a Group Member, the Group Member’s respective rights in the lottery ticket will pass to their estate; this List is binding upon heirs, executors and administrators.
4. Each Group Member releases, indemnifies and saves harmless OLG from any claim with respect to distribution of prize monies to Group Members in accordance with the information contained in this List.
5. OLG assumes no responsibility for a Group Member’s entitlement to any prize, compliance with any laws that may prohibit or restrict groups or individual Group Members from playing lotteries, or for the accuracy of any of the information contained on this List.
